



## Hajj & Umrah Required Docs

1. **Valid Passport** :- 6 Free pages & Valid for 6 months **FROM** date of travel
2. **Photos**:- Colour **PASSPORT** size / White Background / No White Scarf or Fez  
No Smiling / No Spectacles  
**Hajj**: 4 photos / AI AQSA: 6 Photos  
**Umrah**: 2 photos / AI AQSA: 4 Photos

VFS TASHEEL International specifications for visa photos (requirement from the embassy)

**The photograph must be:**

**2 x 2 inches in size (5x5cm)**

- Not more than 06 months old
- Coloured with plain white background
- Full face view of the applicant, facing the camera directly- Side or angled views are not accepted
- Identical, where more than 01 photograph is required to be submitted
- On good quality paper

**The photograph must not:**

- Be torn, creased or marked
- Be trimmed or cut down from a larger photo to the size of the photograph size requirement detailed above
- Have any writing on the front or back

Please refer to the visa category document requirements for details on the number of photographs to be submitted along with your application

3. **Vaccination Card**:- Required Vaccinations: **Meningitis & Yellow Fever**  
(Administered by Registered Travel Doctor)
4. **Marriage Certificate**:- Required for **ALL** married couples
5. **Revert Certificate**:- Required where Name in Passport is a Non-Muslim Name
6. **Mahram Permission Letter**: Required for Women over 45, travelling without a Mahram

**\*\*\* ALL WOMEN UNDER THE AGE OF 45 MUST BE ACCOMPANIED BY A MAHRAM. WOMEN OVER THE AGE OF 45, ARE ALLOWED TO TRAVEL WITHOUT A MAHRAM, PROVIDED THAT THEY TRAVEL WITH AN ORGANISED GROUP AND HAVE A NOTARISED LETTER FROM HER MAHRAM, GRANTING HER PERMISSION TO TRAVEL WITH SAID GROUP.**

**\*\*\* EFFECTIVE FROM 1ST JUNE 2015 CHILDREN UNDER THE AGE OF 18 WILL BE REQUIRED TO TRAVEL WITH AN UNABRIDGED BIRTH CERTIFICATE TOGETHER WITH A PASSPORT. FAILURE TO DO SO WILL RESULT IN THE CHILD NOT BEING ALLOWED TO TRAVEL. PLEASE COMPLY WITH THIS RULE AND REGULATION AS KHIDMATUL AWAAM PILGRIM SERVICES WILL NOT BE LIABLE FOR ANY LOSSES INCURRED SHOULD THE PASSENGER NOT BE ALLOWED TO TRAVEL.**
